AGM Administration Guidance Notes

Venue: The Melton Mowbray Baptist Church is located on Bowling Green, Leicester Road, Melton Mowbray LE13 0FA, opposite the English Indoor Bowling Association Limited Headquarters and the Melton & District Indoor Bowling Club.

Timing: The doors will open at 12 noon with Registration closing at 1.30pm PROMPT. Please allow time to register and collect your Papers

Registration: Please register with the Scrutineers, who will be located near to the entrance door for the Main Hall.

Voting on Resolutions: "<u>Members</u>" of the Association are defined as "Clubs or County Associations that are corporate bodies and Nominee Members of Clubs or County Associations which are unincorporated associations" (Article 2.1).

<u>Members who are "corporate bodies"</u> (in Bowls this usually means that the Club is a Limited Company by Guarantee with Club Members performing the role of Directors), may authorise one of its **Club members** or **County Officials** to be its "**Representative**" at the Annual General Meeting (Article 3.2).

Members who are "unincorporated associations" (in Bowls this usually means that the Club/County is administered by a Committee elected in accordance with a standard form of Club Constitution), may authorise one of its **committee** to be a "**Nominee Member**" to hold the rights of membership on trust for the Club or County Association and to exercise the rights of membership on behalf of the Club/County (Article 3.1).

Each "Representative" or "Nominee Member" will receive the appropriate Voting Cards upon production of the properly authorised "Voting Authorisation Form" to the Scrutineers before the commencement of the meeting.

If a previously notified "Representative" or "Nominee Member" is unable to attend the AGM, an alternative person may attend and vote on behalf of the Club/County, upon production of the correctly completed "Voting Authorisation Form" to the Scrutineer.

Proxy Voting: a Member may appoint a Proxy in respect of Resolutions tabled at the AGM, upon completion of the appropriate Proxy Form.

If a Member Club/County **cannot attend the AGM**, they may either appoint the Chairman of the meeting as their proxy, or a named person who can attend the AGM and vote on their behalf in respect of the RESOLUTIONS ONLY. The appointed proxy can be instructed as to how to vote or they can be allowed to vote as they think fit.

If a Member Club/County **is to be represented at the AGM, IT IS NOT** appropriate to return the Proxy Form.

All Directors voting papers must be received at the Registered Office of the Association by 1.59pm on Thursday 9th September 2021.

All Proxy Forms must be received at the Registered Office of the Association by 1.59pm on Thursday 16th September 2021.

Article 1.1.8 shall be amended to read as follows:

- 1.1.8 "Club" means a club established to promote indoor bowling that has the use of a playing surface, rinks, banks, ditches and other facilities required by the Laws of the Sport of Bowls published from time to time by the current World Indoor Body;

MEMBERSHIP

Article 2.5 shall be amended to read as follows:

- 2.5 The Board may, upon the application of any County Association, permit the County Association to admit to membership a Club that falls outside the area of the County Association but no Club may be a member of more than one County Association at the same time, unless authorised by the Board for reasons that are to the benefit of the Sport of Indoor Bowls"

OFFICERS

Article 38 shall be amended to read as follows:

- 38. At each annual general meeting and subject to Article 39.2:
- 38.1. The Members shall normally elect a Junior Vice-President
- 38.2. However, at the 2021 annual general meeting, due to the impact of the Coronavirus pandemic which resulted in the cancellation of all Indoor Bowling Activities in England from March 2020, the Members shall permit the President, Senior Vice-President and Junior Vice-President, who were installed at the 2020 annual general meeting, to continue to hold office until the 2022 annual general meeting.
- 38.3. With effect from the 2022 annual general meeting, the following procedures shall apply:
- 38.3.1. The Members shall elect a man to be Junior Vice-President in odd years and a woman to be Junior Vice-President in even years or to fill any vacancy which may have arisen by virtue of Article 38.3.4 from nominations received by the Board. A prospective Junior Vice-President or other Officer must be proposed and seconded by Member Clubs and must sign a nomination form to signify his or her willingness to act which contains a description of that person not exceeding 100 words to include details of his or her relevant experience and expertise and must be sent to the Association no more than 120 clear days and no later than sixty clear days before the annual general meeting.

Article 38.2 shall be re-numbered "38.3.2"

Article 38.3 shall be re-numbered "38.3.3"

Article 38.4 shall be numbered "38.3.4" and shall be amended to read as follows:

38.3.4. The Members shall also elect a man or a woman to fill any vacancy which there may be as a result of there being no candidate to succeed to any of the positions referred to in Sub-Articles 1.1 to 38.3.3 (inclusive).

Article 38.5 shall be re-numbered "38.3.5"

DEFINITIONS AND INTERPRETATION

Article 1.1.11 shall be amended to read as follows:

"Directors" means the Directors of the Association; "Independent Directors" means a person who is not a member of a Club.

MEMBERS AND OFFICERS OF THE BOARD

Article 36 shall be amended to read as follows:

36.

- 36.1. Unless otherwise determined by ordinary resolution, the number of members of the Board shall not be less than seven and shall not be subject to any maximum
- 36.2. The Officers shall not be directors ex officio.

PROVISIONS APPLICABLE TO ALL MEMBERS OF THE BOARD

Article 52 shall be amended to read as follows:

52.

- 52.1. No more than one member of the Board may be members of the same Club
- 52.2. The Board may at their discretion appoint Independent Directors who are not members of a Club. Independent Directors shall be appointed pursuant to Articles 36, 39.1, 46 and 51 to 55 (inclusive but excluding 54.1 and 55.6), and shall be appointed for terms of up to three years.

Article 54 shall be amended to read as follows:

- 54. The Board, save those appointed pursuant to clause 52.2, may appoint a person to fill a vacancy in the Board but
- 54.1. the person must be a member of a Club;
- 54.2. any member of the Board appointed under this Article shall hold office until the expiry of the period of office of the member of the Board who created the vacancy

3. Opening Remarks from Chairman of the Board

Mark Cohen welcomed everybody to the Annual General meeting. The Chairman addressed the meeting commenting as follows:

"Good Afternoon Ladies and Gentlemen.

To start I would like everyone to take a few moments to remember the members together with their families that we have lost over the last 15 months. I do not usually single out individual people but on this occasion, I would like to remember with fondness one of my dear friends and fellow Directors, Mr Michael Birch. He was the Presidential Match Director and worked tirelessly for the EIBA, as well as working with great effort in the Disability Bowls movement. Our hearts go out to his wife and family at this time of sadness. May he rest in eternal peace.

Thank You.

I would like to congratulate Mrs Margaret Openshaw for all of her hard work over many years for Bowls in general as well as her support and work in our Human Resources Department. She kept our Office up to date with all of the Laws and Rules that the Government have placed upon us over the last few years. I wish her a happy and healthy retirement.

I would also like to congratulate our President, Alison, who did a terrific job with our Presidential and International games. She was a credit to the EIBA.

We are lucky to have a Chief Executive like Peter Thompson, who is just as comfortable talking to individual Club members as he is with representatives of Government departments, which he has shown over the past few months. The way that he has marshalled our Staff over the past few months has been a credit to him. Big thanks must also go out to our Office Staff, Steve, Joanne, Sue, Claire and Andrea. They have worked from home when required and manned the Office when asked to.

When I took over as Chair last May, one of the first things that we recognised was the decline of Membership over the whole Country. So, we put out surveys to ascertain reasons.

We as a Board decided to ask our Development Director, Michael Lambert, to go out to our Members – both Clubs and Counties, and invite members to attend Seminar to exchange ideas on Recruitment. After all, what works in one Club does not necessarily work in another.

The response was good and bad. Some of the Seminars had attendances of 30 to 40 members. Some were very poor.

After each Seminar, Michael contacted all members for their feedback and that was also very mixed. Based on the Reports that we received at the Board, it showed that there is still a long way to go to get all Clubs to recognise that the Sport does have a Recruitment problem.

Just to try something once without success does not mean that you should give up trying something else until you get the formula that works for you. And YES, it does require work – lots of it. However, if you want our great Sport to survive, a few people in each Club must take charge and work at it.

The EIBA can only give Support and Advice. We cannot do it for you.

We had hoped to cover the whole country, however the pandemic got in the way but we did manage to get a few done. As soon as it is possible, our IT Communications Director Josh Pounds will get together with Michael and will make a Video to put out on our Social Media and Website to give more help and ideas.

I must mention the last few months and it shows how important the EIBA is to each Club and County in England. With Peter in touch with the Government Departments, producing Guideline after Guideline as the Government moved the goalposts, keeping everyone informed. Josh trying to keep our Social Media up to date with information. It has been quite testing as it has been for everyone.

We have had many Zoom meetings and discussed many things including the 2019 Finals and Presidential Games. Again, this has not been straight forward, as nobody including the Government knows what is coming next.

I would like to thank all members of the Board for giving so much of their time to these meetings and putting forward many constructive ideas for the future.

To sum up – the EIBA is very important and when we ask for an increase in per capita subscriptions, it is not to feather our nest. It is just to survive because, as we have seen, we do not know what is next in store for us all.

4. Minutes of the Annual General Meeting of EIBA Ltd held on 18th May 2019

The adoption of the minutes of the Annual General Meeting held on 18th May 2019, was proposed by Arthur Broadberry (Leicestershire CIBA), seconded by Nigel Van Dyk (Deangate Ridge IBC) and duly approved. The minutes were then signed by the Chairman as a true record of the proceedings.

5. Directors Report including Business Review and Financial Report with Audited Accounts

The Chairman referred to the Directors Report, Business Review and Financial Report (with Audited Accounts), which had been circulated.

The Chairman asked Peter Thompson (EIBA Chief Executive) to address the meeting:

"Good afternoon ladies and gentlemen

I refer you to the Directors Report printed on pages 15 and 16 of the 2020 AGM Booklet and the booklet outlining the Financial Statement for the year ending 30th November 2019.

Since the Papers were circulated, I am pleased to advise you that the Auditors have signed off the Accounts and confirmed that they still consider the Company to be a "Going Concern". They have noted that the NCR of £142,000 of deferred income meant no actual Cash Out flow. Further, they have noted that the Directors are closely monitoring the Cashflow and have drawn up plans for the future. The Accounts were signed by the Board on 6th July 2020.

Peter referred to:

- A reduction in Commercial Income due to the uncertainty of Brexit, hung Government and current partners changing business direction.
- Increase in Wages due to a return to full staff compliment. 6 Employees since Incorporation.
- Still keeping core expenditure under control.
- Hire costs increased due to the costs related to a new Photocopier & Printer, which now enables
 the EIBA to produce documents in-house rather than having to pay to outsource their production
 see Printing and Stationery reduced costs.
- Moving forward due to Covid-19 there is uncertainty of Income from Club Levy payments in December 2020
- Budget has been prepared on a "worst case scenario" and will be reviewed again once the 2020 Levy payments have been received.

The Chairman asked the meeting if anybody had any questions to raise.

Mike Jackman (Whiteknights IBC)

❖ Whilst the survival of the EIBA is important, it is also a fact that it is important that the Clubs survive as well in these difficult COVID times. If the Income from the Clubs decreases what action will the EIBA be taking. The Whiteknights Directors were currently considering whether it was viable for them to open until January 2021.

Nigel Van Dyke (Deangate Ridge IBC)

Considered that his Club would only be considering Social and Club League bowling until the situation with COVID and "Team play" becomes clearer.

Peter Thompson advised:

- that it will be necessary to review the level of service that can be provided to Member Clubs and Counties, during this period.
- EIBA is along with other National Governing Bodies looking at sharing Best Practice and or resources.
- Budgets will have to be reviewed regularly
- It will be necessary to see if planned expenditure can be delayed or reduced
- The EIBA is lobbying Government, to make them aware of the plight of Sport NGBs and Clubs

Arthur Broadberry (Leicestershire CIBA)

Enquired as to whether the Sponsorship Agreements were Annual or Three-yearly agreements

Peter Thompson advised:

- that the agreements currently were mainly annual, as companies wanted to see the level of interest.
- Utility Bidder had just renewed
- Fred Olsen unsure as have just laid off staff. They were taking bookings for March 2021 Cruises

The Chairman then sought acceptance of the Directors Report, Business Review and Financial Report (with Audited Accounts) - proposed by Arthur Broadberry (Leicestershire CIBA) and seconded by Mike Jackman (Whiteknights IBC). The meeting accepted the Reports.

6. Formal Ordinary Resolutions from the Board

The Chairman outlined the Procedures that would be undertaken to make a decision in respect of each of the Resolutions:

- a) Joanne Shore would act as Scrutineer, counting the Voting Cards when they are exhibited by the Club and County Nominee Member/Representatives meeting agreed.
- b) The order for showing Voting cards would be:
 - CLUB FOUR VOTES F (Blue), followed by A (Orange), followed by abstentions (Blue or Orange).
 - CLUB TWO VOTES F (Light Green), followed by A (Red), followed by abstentions (Light Green/Red).
 - COUNTY ONE VOTE F (Yellow), followed by A (Pink), followed by abstentions (Yellow/Pink)
- c) In accordance with the Articles of Association, an Ordinary Resolution will be carried if 51% or more of the Total Eligible Votes for those Members in Attendance or by Proxy are cast in favour of the Resolutions. The Total of Eligible Votes had been calculated at 233, with 51% thereby being calculated at 119 Votes.

Annual Levy

6.1 The Board propose that in accordance with Article 5.2, "For the 12 months ending 30th November 2021, the Levy payable by each Club in respect of each of their playing members (who have attained the age of 18 years), as at 1st December 2020, shall be £3.90. This sum to be paid by 31st December 2020.

Due to the on-going COVID-19 situation the EIBA to assist Clubs will for 2020 offer the opportunity to pay the levy in two equal instalments, if required. The first payment will be due by 31st December 2020 and the second by 28th February 2021.

The Chairman formally proposed the motion on behalf of the Board, duly seconded by Nigel Van Dyk (Deangate Ridge IBC).

The Chairman announced that as Chairman she was carrying the following Proxy Votes – 138 (Favour); 78 (Against) and 6 (Abstentions).

The Chairman then asked the Club and County Representatives/Nominee members to vote by using their coloured Voting Cards.

The Resolution was CARRIED – 145 (Favour), 82 (Against) and 6 (Abstentions).

Annual Subscription for Clubs

6.2 The Board propose that in accordance with Article 5.1, "For the 12 months ending 30th November 2021, the annual Subscription for Clubs shall be £110. This sum to be paid by 31st December 2020."

The Chairman formally proposed the motion on behalf of the Board, duly seconded by Arthur Broadberry (Leicestershire CIBA).

The Chairman announced that as Chairman she was carrying the following Proxy Votes – 202 (Favour); 15 (Against) and 5 (Abstentions).

The Chairman then asked the Club and County Representatives/Nominee members to vote by using their coloured Voting Cards.

The Resolution was CARRIED – 213 (Favour), 15 (Against) and 5 (Abstentions).

Annual Subscription for County Associations

6.3 The Board propose that in accordance with Article 5.1, "For the 12 months ending 30th November 2021 the Annual Subscription for County Associations shall be £25. This sum to be paid by 31st December 2020."

The Chairman formally proposed the motion on behalf of the Board, duly seconded by Arthur Broadberry (Leicestershire CIBA).

The Chairman announced that as Chairman she was carrying the following Proxy Votes – 192 (Favour); 11 (Against) and 19 (Abstentions).

The Chairman then asked the Club and County Representatives/Nominee members to vote by using their coloured Voting Cards.

The Resolution was CARRIED – 199 (Favour), 11 (Against) and 23 (Abstentions).

7. Board

7.1 Election of Board Members

In accordance with Articles 45 and 47-49, nominations were sought from Members for the position of Three Elected Directors:

With only TWO nominations being received by the deadlines of 18th March 2020 and then 15th June 2020, in accordance with Article 48.1 the following persons were duly elected:

- David Ian Cable Proposed by Ipswich & District IBC and seconded by Clacton & District IBC.
- Josh Martin Pounds Proposed by Swale IBC and seconded by Hartlepool IBC.

The Chairman advised the meeting that the two vacant Directors positions will be reviewed at the next Directors Board Meeting.

8. Installation/Election of Presidents

Presidential Address

Alison Welsted as Retiring President addressed the meeting:

Alison thanked the meeting for allowing her the honour of being the Associations President.

She commented:

- · that it had been a difficult year
- she had been extremely pleased with all of the players as the British Isles International events
- on a personal note she had found it a "difficult year" due to health issues for herself and her husband
- she apologised if anybody felt that she had let the EIBA down
- that she wished Roger and Carol well for their forthcoming "Presidential Terms"

8.1 Installation of President

The Chairman announced that in accordance with Article 38.2, **Roger Fuller from Mote Park IBC** would be President for the next 12 months.

Alison Welsted presented Roger with his Chain of Office, Presidential Medallion and Plaque.

Roger thanked the meeting for conferring upon him the honour of being the Associations President.

Roger thanked his Club for their support and all of the Staff at EIBA Headquarters for their quidance and assistance to date.

He undertook to do his utmost to uphold the work of the EIBA and he was keen to see more Youngsters and people with Disabilities taking part in our wonderful Sport.

8.2 Installation of Senior Vice-President

The Chairman announced that in accordance with Article 38.2, **Carol Eichen from Rushmoor IBC** would be Senior Vice-President for the next 12 months.

The meeting was advised that Carol was unable to attend due to COVID restrictions. Arrangements would be made to ensure that she received her Senior Vice-President Medallion.

8.3 <u>Election of Junior Vice-President</u>

In accordance with Article 38.1, nominations had been sought for a Male Junior Vice-President.

A total of THREE nominations were received by the deadlines of 16th March 2020 and 15th June 2020.

 In accordance with Article 41, the Board appointed two scrutineers to inspect the Votes:

The Chief Executive advised the meeting:

- that sadly, Michael Birch has passed away on 14th July 2020
- that he had been provided with a written report outlining the result of the voting, declaring that the following votes had been cast:

The meeting agreed to the appointment of "Thomas Westcott" as Auditors on the recommendation of the Chairman of the Board – proposed by Arthur Broadberry (Leicestershire CIBA) and seconded by Nigel Van Dyk (Deangate Ridge IBC).

CLOSE OF BUSINESS

The Chairman thanked everybody for attending and formally closed the meeting.

Open Forum

The Chairman invited Members to table any Questions or comments from the floor for discussion and consideration at future meetings of the Company.

Maurice Mayes (EIBA Life Member)

wished to thank Peter Thompson for his Leadership of the Association and the Board of Directors for the work that they are undertaking.

Mike Jackman (Whiteknights IBC)

thanked the EIBA Team for the COVID "Return to Play" Guidance that had been issued to date and wondered if any further guidance would be issued.

Peter Thompson and Stephen Rodwell assured the meeting that ongoing Guidance will be issued for the foreseeable future

enquired as to the current plans for the 2020/2021 National Competitions

Peter Thompson advised:

- that the situation was still under review, as enquires were being made with Clubs regarding "opening" and "allowing visitors to enter the club"
- currently considering Singles, 2-wood Singles and Pairs to commence in October
- Triples, Fours and "Team events" would then start in the New Year, with the latter being subject to DCMS approval
- Outstanding 2019/2020 Finals rescheduling is still under consideration. The increasing number of potential localised COVID lockdowns could have an impact on Venues and Participants.

Nigel Van Dyke (Deangate Ridge IBC)

• observed that in the 2019 AGM Minutes, the explanation by Gordon Thomas relating to "Irrecoverable VAT" had not been recorded in the Minutes.

Peter Thompson agreed to ensure that such matters were duly recorded in future Minutes

❖ noted from the 2019 AGM Minutes that the matter of "Independent Directors" would be reconsidered by the Directors. He enquired as to the current views of the Board of Directors, as his Club were concerned that there may be more "Non-Bowling Directors" than "Directors with a Bowling background" looking after the affairs of the Association.

Peter Thompson advised that prior to COVID, it had been planned to formally place the matter before the May 2020 AGM. The Board has agreed to move the matter forward as soon as possible, with a limitation on the number of "Non-Bowling Directors"

Peter Thompson (Chief Executive), then updated the meeting on matters raised by Member Clubs and Counties who were unable to attend the meeting due to the COVID restrictions.

- Bedfordshire CIBA thanks for the COVID Guidance
- West Mersea BC "Statement and Proposal relating to Denny Cup & Yetton Trophy"

"At West Mersea BC we want to know why the EIBA is discriminating against the smaller clubs i.e. those with 3 or less rinks. These Clubs have to make a choice of either the Ladies entering the Yetton Trophy or the Men entering the Denny Cup. Most small Clubs have long established friendly games on Saturday afternoons which help in the finances of the whole club. They cannot afford to lose these games.

If common sense were to prevail, the Yetton and Denny would be run on alternating Saturdays and therefore there would be no financial loss from the friendly games and income of the clubs would be increased with the extra morning games"

This point would be considered when the EIBA conducted its review of the National Competition programme at the end of 2021.

 Tony Barclay, Cambridgeshire CIBA – seeking a reply from Chief Executive or Treasurer about the following financial matters:

Why on earth, given the financial situation, did the EIBA spend £12,748 on a chain of office! This I believe is foolhardy and totally unnecessary....

Peter commented that an actual chain was not purchased. The £12,478 is the valuation of the two existing Presidential Chains and why the figure is shown on the balance sheet as an asset.

Your membership income is shown at £285,838 and yet for 6 employees the salary bill is £213,470 plus a further £7,273 in office expenses. Unaffordable I would suggest and rather large for a company of this size?

Peter stated that the 6 employees are responsible for all areas of the association so the overall income of the company should be used, not just the Membership. Therefore with turnover being £507,802 the wage bill is 44% of income to provide all year round support / guidance to the member clubs, counties and individual bowlers.

You state that the cost of the International Championships was £73,762 in 2019 - £10,000 MORE than in 2018. What does the money provide in positive terms to the general member of any club and what is the money ACTUALLY used for? I suggest that this be seriously looked at as a way of saving money.

The International programme is an essential activity for the sport of Indoor Bowls. It is the tip of the player pathway for participants, as well as showcasing the sport for the club bowler and potential bowlers. The money spent on Internationals will vary year by year due to where the events are held in the British Isles. Also, if England has to host any of the events, as we did in 2019, this does lead to one off expenditure to get the venue ready to host.

The core expenditure covers the travel, accommodation, meals and kit for new players. These areas are continually monitored to ensure only necessary expenditure.

The financing of the International programme is done via the National Competition income but yes if there is a shortfall, the balance is covered by commercial and membership income.

Coach Bowls position and when do you see any profit from your investment?

Coach Bowls is the sport of bowls recognised coaching body and in the last year EIBA and Bowls England agreed to take ownership, on equal terms, from the Bowls Development Alliance. There are contractual arrangements with British Crown Green and English Short Mat to ensure the continued sport wide reach of Coach Bowls.

There is a commitment from the NGBs to work with the EBCS to successfully integrate them into the coaching structure for the sport of Bowls.

It is the intention that over the next three years the level of investment by EIBA and BE will be reduced annually as the level of income generated by Coach Bowls increases. As coaching is vital to the continued growth of participants the aim is for Coach Bowls to be self-supported and re-invest any surplus back into developing coaching as a whole.

What exactly are you intending to do to rectify this mess?

The EIBA will consult with the membership on what activities they wish to see for the sport and only focus on these activities. In addition, the sport will need to accept that there has to be a more meaningful level of income for the Association to govern the sport. It has been continually referred to by our auditors that the level of membership levy needs to be at least £5.00.

5. DIRECTORS REPORT - ACCOUNTS SEE SEPARATE BOOKLET

DIRECTORS' REPORT For the period ended 30 November 2020

The Company started the new year with optimism. The uncertainty in the Country through Brexit was finally removed and with it, positive discussions with potential commercial partners had begun to start again.

A continued focus on controlling core expenditure, whilst still providing full governance of the sport was still the key focus of the Company. This activity is reflected in the year's financial performance

COVID-19, as will be referred to throughout this report, had an impact not only the playing of the sport but also on the financial activities. The Company utilised the Government grants / schemes to secure income and cover expenditure. In addition, the Company secured a £143,000 grant from Sport England to cover the core expenditure and shortfall in projected income.

As a result, the Company have returned a surplus of £91,455 before taxation for the financial year. (see the annual accounts booklet).

At International level England had a good season. There were British Isles titles for the Senior Men, Senior Women and U25 Women whilst the Men's U25 and U18 mixed team secured hard fought second places.

The Company hosted the Men's U25 British Isles International Series / Championships and were delighted with its selected venue, Stanley Indoor Bowls Club. Once again, the Club and its members staged an excellent event and ensured all participants had an enjoyable event.

Then as the 2019-2020 was nearing the final phases we were all affected by the arrival of the Coronavirus pandemic. Fortunately, several of the National Competitions were able to be concluded before the Country went into lockdown in March. However, this meant that the National Finals weeks had to be postponed, with the aim of re-scheduling them later in the year.

The focus of the Company for the remainder of the year, especially with the ever, changing situation regarding COVID-19, was to provide appropriate guidance to its Indoor Clubs and County Associations on how they could prepare to re-open once indoor sport was allowed to take place.

The Company continued to use its portfolio of social media platforms (Facebook, Twitter and Instagram). These have proved to be successful in getting information on the sport out as clubs faced extended periods of closure.

The Company would like to thank all its member Clubs, County Associations, individual bowlers, the Head Office staff and volunteers for their support, understanding and constructive feedback as we managed our way through the continued challenges of COVID-19.

The Year Ahead - As of August 2021

The current year will undoubtably prove to be a tough one for the Company and its member Clubs and County Associations. Despite the sport being able to take place at the start of the new season it was soon impacted by a resurgence in COVID-19 and the necessary Government restrictions and two further National Lockdowns to reduce the number of cased and deaths.

Consequently the 2020-2021 season has only been able to take place on a limited and controlled basis. Ultimately this has had a severe impact on the sports finances and activities.

The Company cancelled the 2020-21 National Competitions with all entries being deferred until next season or refunded. With Clubs seeing their membership numbers fall due to no bowls the income from Affiliation and Levies is expected to be at least 50% lower than the previous year.

However, now that the Country has returned to a more normal way of life, with COVID-19 restrictions being removed we will be working with the clubs on how they can promote the benefits of Indoor bowls to attract new members but more importantly demonstrate to their current members that they can once again enjoy the sport in a safe and friendly environment.

The re-scheduled 2019-2020 National Finals will take place at the end of September to mid-October alongside the start of the 2021-2022 season.

If there are any more challenges along the way the EIBA will work with all clubs to ensure the sport develops and adapts to continue being a sport for all.

6. FORMAL SPECIAL RESOLUTIONS FROM THE BOARD

6.1 **DEFINITIONS AND INTERPRETATION**

Article 1.1.8 shall be amended to read as follows:

1.1.8 "Club" means a club established to promote indoor bowling that has the use of a playing surface, rinks, banks, ditches and other facilities required by the Laws of the Sport of Bowls published from time to time by the current World Indoor Body:

Recommendation from the Board FOR

This article change is required as there is now only one Laws of the Sport of Bowls, the Crystal Mark version.

6.2 **MEMBERSHIP**

Article 2.5 shall be amended to read as follows:

2.5 The Board may, upon the application of any County Association, permit the County Association to admit to membership a Club that falls outside the area of the County Association but no Club may be a member of more than one County Association at the same time, unless authorised by the Board for reasons that are to the benefit of the Sport of Indoor Bowls"

Recommendation from the Board FOR

The Board wishes to have the ability to allow Clubs to be a member of an additional County Association for reasons which would benefit Indoor Bowls in that area. For example their main County Association may not run County Competitions and or enter EIBA National County Competitions which limits the playing pathway for their club members..

6.3 OFFICERS

Article 38 shall be amended to read as follows:

- 38. At each annual general meeting and subject to Article 39.2:
- 38.1. The Members shall normally elect a Junior Vice-President
- 38.2. However, at the 2021 annual general meeting, due to the impact of the Coronavirus pandemic which resulted in the cancellation of all Indoor Bowling Activities in England from March 2020, the Members shall permit the President, Senior Vice-President and Junior Vice-President, who were installed at the 2020 annual general meeting, to continue to hold office until the 2022 annual general meeting.
- 38.3. With effect from the 2022 annual general meeting, the following procedures shall apply:
- 38.3.1. The Members shall elect a man to be Junior Vice-President in odd years and a woman to be Junior Vice-President in even years or to fill any vacancy which may have arisen by virtue of Article 38.3.4 from nominations received by the Board. A prospective Junior Vice-President or other Officer must be proposed and seconded by Member Clubs and must sign a nomination form to signify his or her willingness to act which contains a description of that person not exceeding 100 words to include details of his or her relevant experience and expertise and must be sent to the Association no more than 120 clear days and no later than sixty clear days before the annual general meeting.

Article 38.2 shall be re-numbered "38.3.2"

Article 38.3 shall be re-numbered "38.3.3"

Article 38.4 shall be numbered "38.3.4" and shall be amended to read as follows:

38.3.4. The Members shall also elect a man or a woman to fill any vacancy which there may be as a result of there being no candidate to succeed to any of the positions referred to in Sub-Articles 1.1 to 38.3.3 (inclusive).

Article 38.5 shall be re-numbered "38.3.5"

Recommendation from the Board

FOR

The 2020-2021 Season being severely impacted by COVID-19, the Board wishes that the "Presidential Chain" be able to serve the Association as intended. Therefore all Officers will remain in the position they were elected to in 2020.

6.4 **DEFINITIONS AND INTERPRETATION**

Article 1.1.11 shall be amended to read as follows:

"Directors" means the Directors of the Association; "Independent Directors" means a person who is not a member of a Club.

MEMBERS AND OFFICERS OF THE BOARD

Article 36 shall be amended to read as follows: 36.

- 36.1. Unless otherwise determined by ordinary resolution, the number of members of the Board shall not be less than seven and shall not be subject to any maximum
- 36.2. The Officers shall not be directors ex officio.

PROVISIONS APPLICABLE TO ALL MEMBERS OF THE BOARD

Article 52 shall be amended to read as follows: 52.

- 52.1. No more than one member of the Board may be members of the same Club
- 52.2. The Board may at their discretion appoint Independent Directors who are not members of a Club. Independent Directors shall be appointed pursuant to Articles 36, 39.1, 46 and 51 to 55 (inclusive but excluding 54.1 and 55.6), and shall be appointed for terms of up to three years.

Article 54 shall be amended to read as follows:

- 54. The Board, save those appointed pursuant to clause 52.2, may appoint a person to fill a vacancy in the Board but
- 54.1. the person must be a member of a Club;
- 54.2. any member of the Board appointed under this Article shall hold office until the expiry of the period of office of the member of the Board who created the vacancy

Recommendation from the Board FOR

By having the power to appoint Independent "non-executive" Directors to fill vacant positions the Board will be able to expand the knowledge and experience available to it and become a stronger Board. In addition, this move ensures the association is compliant with the Code of Governance, issued by Government and their agencies. The Board will retain the ten positions elected from Member Clubs which means the Board need to implement a minimum number of Directors rather than having a fixed maximum.

6.5 **PROCEEDINGS OF THE BOARD**

Article 60 shall be amended to read as follows:

The quorum for the transaction of the business of the Board may be fixed by the Board and unless so fixed at any other number shall be five

Recommendation from the Board FOR

With the Board wanting to have a minimum number of seven Directors, the number needed for a quorum will be five instead of 6.

7. FORMAL ORDINARY RESOLUTIONS FROM THE BOARD

Annual Levy

7.1 The Board propose that in accordance with Article 5.2, "For the 12 months ending 30th November 2022, the Levy payable by each Club in respect of each of their playing members (who have attained the age of 18 years), as at 1st December 2021, shall be £4.00. This sum to be paid by 31st December 2021.

Recommendation from the Board FOR

The Board will continue with its policy to make small increments annually to help the ongoing governance of the sport. As requested from Clubs to aide their own financial planning the Board intends to seek an increase in the levy to between £4.10 and £4.20 at the 2022 AGM.

Annual Subscription for Clubs

7.2 The Board propose that in accordance with Article 5.1, "For the 12 months ending 30th November 2022, the Annual Subscription for Clubs shall be £110. This sum to be paid by 31st December 2021."

Recommendation from the Board FOR

The Board wishes to keep the Annual Subscription the same.

Annual Subscription for County Associations

7.3 The Board propose that in accordance with Article 5.1, "For the 12 months ending 30th November 2022 the Annual Subscription for County Associations shall be £25. This sum to be paid by 31st December 2021."

Recommendation from the Board FOR

The Board wishes to keep the Annual Subscription the same.

8. BOARD

8.1 Election of Board members – report on Votes cast by Clubs. The Four Candidates with the highest number of Votes will be elected for a period of three years.
